### **MPOWER DYSLEXIA Scholarship Application 2022**

Welcome to Dyslexia On Demand and our MPOWER DYSLEXIA Scholarship Application! MPOWER DYSLEXIA 503c3 is a non-profit who fundraises throughout the year to scholarship a student through free dyslexia therapy.

- **The scholarship will be based on financial need, social-emotional impact, and the severity of dyslexia.**
- 2022 applications will be accepted through November 30.
- The recipient will be chosen and contacted in December with services set to begin the first week of the new year!
- Therapy typically is designed to be delivered over 2 years, although the most severe cases of dyslexia can take longer to remediated. This scholarship will cover 48 weeks of instruction at a four time a week rate. Anything addition may need to be covered with the family, at a reduced rate, if deemed necessary.
- **Financial need requirements are listed below. Once a student is chosen, we will require 2018, 2019, and 2020 tax returns for verification of income.**
